We disagree. The trial court found the testimony of the State’s witnesses and viewed the evidence in the light most favorable to the State. In so doing, the trial court found the testimony of the State’s witnesses to be credible. This Court gives due regard to the trial court’s opportunity to observe the witnesses’ demeanor and credibility. State v. Surlee, 446 S.W.3d 634, 641 (Mo. App. W.D. 2014). “[W]e must defer to the trial court’s credibility determinations.” Id. In our review, we presume that the trial court’s findings of fact are correct. State v. Miller, 321 S.W.3d 730, 731 (Mo. App. W.D. 2010). The evidence presented was sufficient to establish that Appellant was the driver of the vehicle that caused the accident and that he was under the influence of intoxicating
